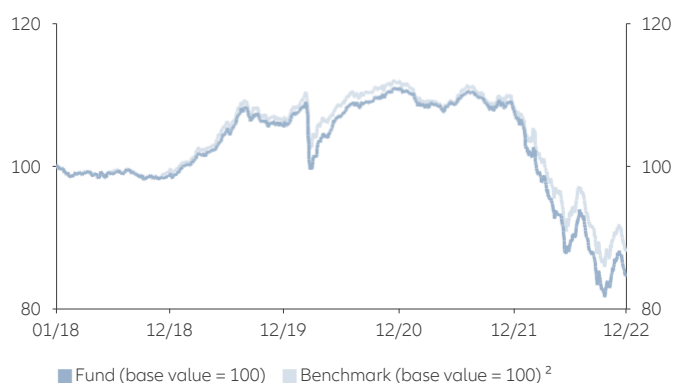

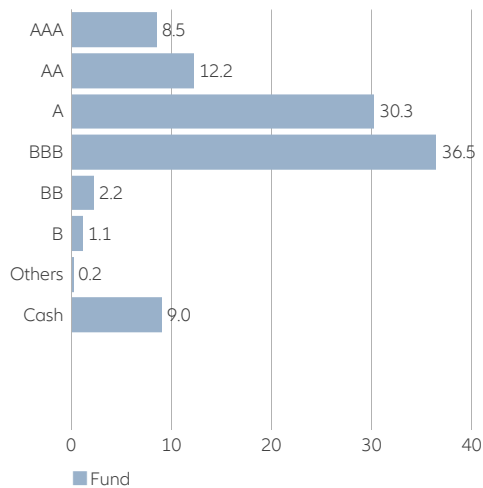

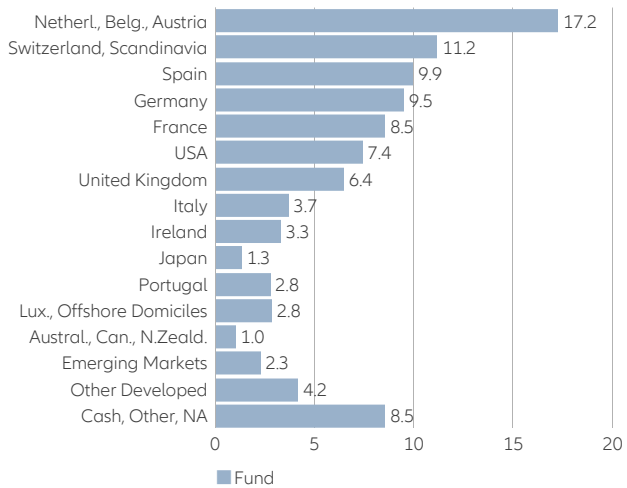
Rating Breakdown (%) (weighted by market value) <sup>7</sup>



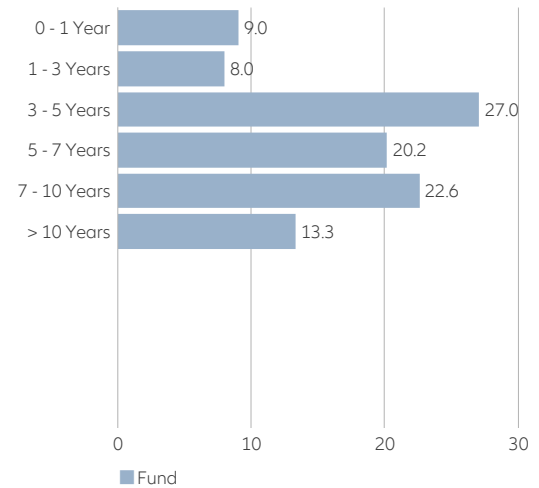
